#### Tax Tip: Ethical Tax Planning vs. Risky Tax Avoidance

In September, we joined a CIBA webinar led by Johan Heydenrych that focused on the fine line between responsible tax planning and impermissible tax avoidance.

Ethical tax planning means structuring your business in a way that follows sound commercial practice while legitimately minimising your tax burden. By contrast, "avoidance arrangements" designed purely to escape tax, especially those lacking commercial substance, can expose businesses and their directors to SARS penalties, reputational damage, and even personal liability.

The message is simple: plan early, document carefully, and always ensure tax decisions are backed by both legal compliance and solid business reasons. Good planning saves money, but reckless schemes cost much more.

#### Important Deadlines & Reminders – October 2025

Deadline	Details	Notes
7 October 2025	PAYE, UIF, SDL returns (EMP201)	Must always be submitted <b>by the 7th</b> . If the 7th falls on a weekend/public holiday, the due date is <b>shortened to the last working Friday before</b> .
20 October 2025	Personal Income Tax (IT12) submission deadline	Missing this deadline will result in <b>SARS</b> administrative penalties. File early to avoid issues.
25 October 2025	VAT Returns (VAT201) – bi- monthly (uneven month cycle)	Ensure all supporting invoices are in order before filing.
31 October 2025	Provisional Tax – First payment for companies with April 2026 year-end	Ensure calculations are accurate to avoid penalties.
31 October 2025	Provisional Tax – Second payment for companies with October 2026 year-end	Keep supporting documentation ready in case of queries.
